- C. <u>Discussion of Floodplain Progress for Kirkland Sawmill</u>- President Block gave an update on the progress of getting the Sawmill items cleaned up and moved back. He has moved some things but still has areas that need to be done. He still has some piles that need to be moved out in the back and pillars that need to be moved and some that need to be installed. We had given him until the end of March, but due to weather he has not been able to get it done. The Board would like to give him a new date of May 1st for the completion of the work. They also have two big piles of mulch that is getting out of hand. President Block to do a follow-up with them. They had bought property back behind them to the south, they would like to do some excavating there and backfill with gravel. This is something that they will have to get a permit for IDNR and not the Village. President Block asked Attorney Brad Stewart to draft a letter giving them until May 1st to become compliant.
- Discussion of Proposed Water and Sewer Billing Usage Rate- President Block gave a breakdown on the new Water and Sewer Rates with the Bull Run Creek Project fees and a Water and Sewer Capital Improvement fee on every bill.
