- I. Call to Order Village President Block called the meeting to order at 7:00 P.M. and asked for a roll call.
- II. <u>Roll Call Members answering present as follows: Trustee Ford, Trustee DeVlieger, Trustee Wiegartz and Trustee Ziegler (joined the meeting at 7:18 P.M.). Trustee Micele and Trustee Harvel are absent.</u>
- III. Pledge of Allegiance President Block led us in the Pledge of Allegiance.
- IV. Comments from the Audience Property owner of 518 Main St., Mr. Mike Hemme, received the letter regards to an Ordinance that was passed in 2008. Mr. Hemme would like to ask for a variance for his property. Attorney Brad Stewart explained to Mr. Hemme the process on how to request a variance.   - Semper Fi Land Inc. Not allowed due to not meeting Bid Requirements

Chad Clauson from Fehr Graham recommended that the bid be awarded to William Charles in the amount of \$489,987.13. President Block asked for a motion to award the bid for the Bull Run Creek Water Storage Project to William Charles in the amount of \$489,987.13 along with \$39,200.00 to Fehr Graham for Bull Run Creek Construction Observation and Contract Management. Trustee Ford made a motion to award the bid for the Bull Run Creek Water Storage Project to William Charles in the amount of \$489,987.13 and Engineering services to Fehr Graham in the amount of \$40,000.00, with a 2<sup>nd</sup> by Trustee DeVlieger. On a roll call vote Trustees DeVlieger, Wiegartz, Ziegler and Ford voted yes, Trustees Harvel and Micele are absent. Motion carried.
