- 4. <u>Police Squad Car Trade In</u> Motion by McMurray, D. and seconded by Ford to trade in old police squad car in for a value of \$300.00 against purchase of new squad car. On a roll call vote Pierce, Ford, Ziegler, McMurray, W., Newberry, and McMurray, D., voted yes. Motion passed.
- 5. <u>Change Order No.1/2014 Sanitary Sewer System Rehab</u> Motion by Ford and seconded by Newberry to accept change order No. 1 as presented by Baxter &

Woodman. On a roll call vote Ziegler, McMurray, W., Newberry, McMurray, D., Pierce, and Ford voted yes. Motion carried.
