- 1. <u>Key Fob Entry for Public Works</u> Chief Lindstrom reported that after contacting Metro Security who provided key fob entry for village hall that approximate cost for both doors to be \$2500.
- 2. Security Cameras at Public Works and Additional Public Areas Chief Lindstrom reported that after contacting Metro Security who provided security cameras at village hall that approximate cost would be \$200/camera and which will be integrated with current security system at village hall as well as wireless. Chief Lindstrom will confirm prices after representative visits property to view exact locations. Item moved to next agenda.
- 3. <u>Disposition of Property at 419 Main Street</u> Trustee Ford reported that quote received from Northern Illinois Services (demolition company) at approximately \$10,000. Items needed prior to demolition include asbestos report, water/sewer cap location, and final grading decision of rock or soil/grass. Board consensus was to have Ford pursue additional quotes from additional demolition companies and report back to board. Item moved to next agenda.
