- I. Call to Order President Block called the meeting to order at 7:00 P.M. and asked for a roll call.
- II. <u>Roll call</u> Members answering present as follows: Trustee Ford, Trustee Chambers, Trustee Ziegler, Trustee Wiegartz and Trustee DeVlieger. Trustee Fruit is absent.
- III. Pledge of Allegiance President Block leads us in the Pledge of Allegiance.
- IV. Comments from the Audience None
- V. <u>Approval of Minutes</u> President Block asked for a motion to approve Regular Board Meeting Minutes for Monday, August 5, 2019. Trustee Ziegler made a motion to approve the Regular Board Meetings Minutes for Monday, August 5, 2019 with a 2nd by Trustee Chambers. On a roll call vote Trustees Ford, Chambers, Ziegler, Wiegartz and DeVlieger voted yes. Trustee Fruit is absent. Motion carried.
- VI. Approval of Warrant President Block asked for a motion to approve the Warrant in the amount of \$55,110.65. - a. Financial Report Nothing
- b. Police Report Officer Saladino reported that the Department had 128 reportable calls for the month of August 2019. Chief Davenport is out attending the IEMA Conference in Springfield, but he would like to give kudos to Officer Saladino for his arrest of a registered sex offender in Pioneer Park, good police work and Thank You Officer Saladino. Police Committee Meeting scheduled for September 18th at 7:00 P.M. Chief Davenport and Officer Trevor Owen will be meeting with school administration on Friday, September 6th to go over the plans for the remainder of the school year. Some of the things that will be discussed are: ALICE Training, School Police Office, Introduce Officer Owen to school staff and the "Too Good For" Program.
- c. <u>Public Works</u> Public Works Superintendent Dale Miller reported that the they are working on cleaning up and hauling all material out of the current Public Works Facility. We will also begin construction on a temporary salt bin and use a tarp to cover it for this year. They have also begun cleaning and restoring the Public Works lot as well as the Public Works WWTP Facility as time and weather permits. We are also going to be winterizing our equipment and repairing snow equipment as time permits over the next three months. As we finish projects, we will then begin mowing weeds and cleaning up along Bull Run Creek again.
- d. <u>Kirkland Community Center</u> Linda Fett reported that Representative Jeff Keicher will be here on Friday, September 6th and there is a potential \$100,000 Grant that is available to the Village that they are going to talk to him about. The Committee had sent them a copy of the plans about three weeks ago. Rep. Keicher's office did not want anything else, they wanted to look over the plans so that is all they wanted at this time.

- VIII. <u>Guest Speaker</u> Dawn Darling did not really have any new information just wanted to know if we went over the paperwork that she handed out at the last meeting. Trustee Wiegartz brought up the no planting in the parkways and the reason for this is because of the sewer lines that run to the street. Dawn explain that there are different trees that can be planted in the parkways as well as ones that can be planted in cut outs. President Block explained that on the agenda under New Business he is asking for Board approval to put together a Tree Advisory Panel. This panel will be made up of 3 or 4 residents, Public Works Superintendent Dale Miller, Village President Block and one of the Streets, Alleys and Parks Committee member. This panel would then take their notes and items back to the Streets, Alleys and Parks Committee.

IX. Unfinished Business-

- a. <u>Update on Water and Sewer Mapping for the Village of Kirkland</u> President Block brought up the new water & sewer mapping that was done this summer on the computer and TV for the trustees to view. The new mapping shows were all B-Boxes are in the Village, so when our Public Works go out to any home, they can pull this up on their phones, so they know right where your B-Box is located. Next year they will be adding another layer to include additional items, such as location of all fire hydrants.
- b. <u>Discussion and Approval of the Wastewater SCADA Improvement at Wastewater Treatment Plant and Lift Station #4</u> Dale Miller explained what and why the SCADA system is important to the Wastewater Treatment Plant and Lift Station #4. These areas will be tied into the SCADA System on the Water and Sewer side. Trustee Ford made a motion for the approval of the Wastewater SCADA Improvement at the Wastewater Treatment Plant and Lift Station #4 not to exceed \$46,000.00 with a 2nd by Trustee DeVlieger.
