- a. <u>Discussion/Approval of the Village of Kirkland Financial Report for Fiscal Year 2021-2022</u> President Block asked for a motion for the approval of the 2021/2022 Financial Report for the Village of Kirkland. Trustee Ziegler made a motion for the approval of the Village of Kirkland 2021/2022 Financial Report, with a 2nd by Trustee Chambers. On a roll call vote Trustees, Marshall, Fruit. Ziegler, Michener, Benes, and Chambers voted yes. Motion carried.
- b. <u>Discussion/Approval of Ordinance 2022-06/Ordinance Amending Title VII, Section 71.01</u>
 Regarding Parking Recreational Vehicles on Unimproved Surfaces President Blocked asked for a motion to approve Ordinance 2022-06/Ordinance Amending Title VII, Section 71.01
 Regarding Parking Recreational Vehicles on Unimproved Surfaces. Trustee Marshall has some concerns with having quantity of no more than two recreational vehicles on a zoning lot.
 Trustees feel that one may have more than two recreational vehicles and if their driveway can accommodate such vehicles they should not be restricted. - f. <u>Discussion of 2022/2023 Village of Kirkland Tax Levy</u> Village Treasure Bill Newkirk put together the 2022/2023 Village of Kirkland Tax Levy. This is just here for review, if nothing stands out, we will work with Bill to have it put in Ordnance form and pass it at the November 7, 2022 Board Meeting. If anyone has concern, please contact the Village President Ryan Block.
- g. <u>Discussion of Selection and Hiring Process for two (2) Full-time Police Officers</u> Chief Davenport would like to begin the process and put together a procedure for selecting and hiring two Full-time Police Officers. Will have a Police Committee Meeting and discuss what this is going to look like. Will present the proposal at the December 5, 2022 Board Meeting.
- h. <u>Discussion/Approval for Chief Davenport to attend Staff and Command Training in February 2023</u> Chief Davenport would like to attend Staff and Command Training in February 2023 that is going to be given in Rockford. This is a 10-week training course for Chiefs and Sergeants. President Block asked for a motion for the approval for Chief Davenport to attend Staff and Command Training in February 2023. - j. <u>Discussion/Approval of new Rifle for Kirkland Police Department</u> Currently the rifle that is used in Chief Davenport's car is his personal rifle. Trustee Fruit asked if this would relieve him from using his personal equipment, which Chief indicated it would. For that reason alone, Trustee Fruit made a motion for the approval to purchase a new rifle for the Kirkland Police Department not to exceed \$1615.00, with a 2nd by Trustee Ziegler. On a roll call vote Trustees Michener, Benes, Chambers, Marshall, Fruit, and Ziegler voted yes. Motion carried.

On a roll call vote Trustees Benes, Chambers, Marshall, Fruit, Zeigler, and Michener voted yes. Motion carried.

Village of Kirkland Public Works Report for September 2022

Task underway and completed

- Continued cleaning of the Public Works garage and property.
- Aerators In lagoon system were cleaned out of debris and greased.
- We added Sludge RX and "action packs" for the final treatment of the year.
- Numerous water meters replaced/ updated to radio reads.
- Removed stump grindings and replaced with dirt, fertilizer, and grass seed.
- Walking path was rolled and compacted with a vibratory roller (machine usage donated by employee Gary Nepperman).
- We had to re-nail the trim on the Public Works building that was put on in 2020 I believe from fuller Construction with long staples.
- Spray weeds at new Public Works lot.
- Spray weeds around town in cracks on roadways and sidewalks in downtown area.
- Spray weeds around lagoon system and current Public Works buildings.
- Continue marking "Julies" on a daily basis for the water dept.
- Repair new damaged culvert in alley on South 6th Street.
- Replaced driveway culvert at 212 North 6th Street and raised B-box to proper height.
- Purchased 6 new plastic barricades and lights.
- Purchased boards and shelf brackets for Police dept. and installed them in the garage.
- Spoke with Davey Tree Service/ Com Ed's sub-contractor about trees in power lines on Pearl and on Main Street, never received a call back.
- Dragged alleys with the ford tractor to alleviate the potholes.
- Double check 302 S. 6th Street's water meter for homeowner's concern of high usage.
- Sunday Sept.11th I received calls from the DeKalb Co. Sheriff, Ryan Block, and Chris in regards to
 flooding at the Lutheran church during the 5 inch rain fall. The storm sewers were not
 completed at that time due to a gas line running through the area. The gas line has been
 rerouted to complete the South St. sewer system.
- Met with Ryan Block for a meeting with IDOT to find out that we will not have paving on Rt.72 through town until next spring and that it should be completed by June 24,2023.
- Water tower was inspected for painting and cleaning.
- Nicor's gas service lines on South St. were shallower than expected, some were hit and repaired as the road project moved along.
- Washed and cleaned backhoe and new skid steer for the "touch a truck" event at Fall Fest.
- Clean up weeds and thistles at Behnke park.
- Placed "No Parking 2am-6am" sign at north end of 5th St. and railroad alley.
- Replaced burnt out streetlight bulb on Main St.
