X. Resolutions, Ordinances, and Miscellaneous Business

1. Ordinance 15-09/Levying & Assessing Taxes of the Village of Kirkland for the Fiscal Year Starting May 1, 2015 and Ending April 30, 2016 — Amended motion by McMurray, D., to include Kirkland Municipal Library with 2nd by Ziegler to pass as read. On a roll call vote McMurray, D., Harvel, Ford, Ziegler voted yes, Micele voted no, McMurray, W. abstained. Motion carried with 4 yea votes.

- 2. <u>IL SB 2039</u> Mayor Bellah indicated that bill passed unanimously, which makes appropriations for Motor Fuel Tax and Video Gaming Tax to be sent to local municipalities.
- 3. <u>Refuse Pick Up Times</u> Question regarding time for refuse pick up was raised. Clerk to follow up with Waste Management.

XI. New Business

- 1. Boy Scouts Monetary Donation Eagle Scouts planted trees with donated funds in the village. Remaining donation of \$245.00 was given to the village in accordance with their By-Laws. After much discussion, motion by McMurray, D., with 2nd by Harvel to deposit funds in General Fund account with determination of appropriation to be determined at a later date. On a roll call vote McMurray, D., Harvel, Ford, Ziegler, McMurray, W., Micele voted yes. Motion carried.
- 2. Engineering Services for Final Design & Permitting for Bull Run Compensatory Storage Area Engineer Sparber presented memo dated December 4, 2015 from Baxter & Woodman to board for engineering services related to Bull Run Creek. Contract does not include soil classification (possible cost of approximately \$12,000) nor permit applications (possible cost of \$5000). After much discussion, motion by McMurray, D. with 2nd by McMurray, W., to authorize Mayor Bellah to enter into contract agreement with Baxter & Woodman as presented for a not to exceed amount of \$34,400. On a roll call vote Harvel, Ford, Ziegler, McMurray, W., Micele, McMurray, D. voted yes. Motion carried.
- 3. <u>Employee Appreciation Checks</u> Motion by Harvel with 2nd by McMurray, W., to authorize expenditure of \$50.00 per FTE for employee appreciation. On a roll call vote McMurray, W., Micele, Harvel voted yes, with Ford, Ziegler, McMurray, D. voting no. Tie vote with Mayor Bellah voting yes to break tie. Motion carried.

XII. Executive Session

Motion by McMurray, D., with 2nd by Ford to move to Executive Session to discuss Personnel under Section 2 (c) (1), and Purchase or Sale of Real Estate under Section 2 (c) (5). On a roll call vote Ford, Ziegler, McMurray, W., Micele, McMurray, D., Harvel voted yes.

Motion by McMurray, D. with 2nd by Ziegler to return to regular session. On a roll call vote Ziegler, McMurray, W., Micele, McMurray, D., Harvel, Ford voted yes.
