- V. <u>Approval of Minutes</u> President Block asked for a motion for the approval of the General Board Meeting Minutes for Monday, March 6, 2023. Trustee Fruit made a motion to approve the General Board Meeting Minutes for Monday, February 6, 2023, with a 2nd by Trustee Michener. On a voice call vote, all in favor. Motion carried.
- VI. <u>Approval of Warrant</u> President Block asked for a motion to approve the Warrant in the amount of \$61,837.67. Trustee Ziegler made a motion to approve the Warrant in the amount of \$61,837.67, with a 2nd by Trustee Fruit. On a roll call vote Trustees Chambers, Marshall, Fruit, Ziegler, Michener, and Benes voted yes. Motion carried.

- c. Committee Report-
 - 1. Tree Committee Trustee Benes gave an update on the March 21, 2023 Tree Committee meeting. On April 28, 2023, the Tree Committee with be planting a White Swamp Oak in Behnke Park at 4:30 P.M. in celebration of Arbor Day. Their next meeting will be Tuesday, April 25,2023 at 7:00 P.M.

 - a. <u>Discussion/Approval of Contract with Hopkins and Associates for 2022-2023 Village of Kirkland Audit Service</u> President Block asked for a motion to approve the contract with Hopkins and Associates for our 2022-2023 Village of Kirkland Audit Service. Trustee Ziegler made a motion to approve the contract Hopkins and Associates for our 2022-2023 Village of Kirkland Audit Service not to exceed \$9000.00, with a 2nd by Trustee Michener. On a roll call vote Trustees Fruit, Ziegler, Michener, Benes, Chambers and Marshall voted yes. Motion carried.
 - b. <u>Discussion/Approval of village of Kirkland 50/50 Cost Sharing Program with Parkway</u> President Block turned this over to Trustee Benes to give the Village Board some insight. There

will be two plantings each year, one in the Spring and then one in the Fall. After much discussion, President Block asked for a motion for the approval of Village of Kirkland 50/50 Cost Sharing Program for Parkway Trees. Trustee Benes made a motion to approve the 50/50 Cost Sharing Program during 2023 Spring and Fall planting cycles, for total cost of tree and planting provided by St Albans Nursery, pending permit approval by Superintendent of Public Works and considering recommendation of Kirkland Tree Commission were practical. - c. <u>Discussion of Amendments to Village of Kirkland Ordinance Chapter 92: Trees and Shrubs</u> President Block explained what the Amendments will be with the Ordinance Chapter 92. Attorney Stewart will update the Ordinance and submit it at the next General Board Meeting.
- d. <u>Discussion/Approval of Village of Kirkland Public Works Salt Barn Paving Project</u> President Block turned this over to Jeff Jacobson from Fehr-Graham. Fehr-Graham had put this paving project out for bid and bids were open at 11:00 A.M. on April 3, 2023. There were 5 companies that submitted bids. The lowest bid was Martin and Company out of Oregon, IL that came in at \$63,475.00. Fehr-Graham recommend that we award the bid to them. Trustee Ziegler made a motion for the approval of Village of Kirkland Public Works Salt Barn Project to Martin and Company out of Oregon, IL in the amount of \$63,475.00, with a 2nd by Trustee Fruit. On a roll call vote Trustees Benes, Chambers, Marshall, Fruit, Ziegler and Michener voted yes. Motion carried.
- e. <u>Discussion of Village of Kirkland Fiscal Year 2023-2024 Budget</u> President Block gave an update on where the 2023-2024 budget is at. Final step is for all departments to make any and all final adjustments.
