- f. <u>Discussion of Village Code 112.11 for Sale of Dispensing of Alcohol Beverages age Restriction to Match recent change to Illinois Law</u> President Block had been approached by Red Brick by the fact that as they were doing their Basset training, they saw that per the State of Illinois you only have to be 18 years of age to pour and serve alcohol. After looking into this and not finding anything we turned it over to Attorney Brad Stewart. He said that as of January 1, 2021, the State lowered the age. The only thing that is holding them back is our Ordinance that states they must be 21. Some of the Trustees would like to have the Ordinance read that they can serve and pour but will have someone 21 or older there with them, so they cannot be opening and closing a bar by their self.
- g. <u>Discussion of OMA and FOIA Training Conducted by DeKalb County States Attorney Rick Amato in May 2022</u> President Block shared the information from DeKalb County Attorney Rick Amato. He will be conducting an OMA & FOIA training in May 2022 if anyone would like to go.

- h. <u>Discussion of Village Property at Northwest Corner of Illinois Route 72 (Main Street) and 6th Street Received information back from IDOT stating that the property at the corner of Illinois Route 72 and 6th St. belongs to the Village. The thought is now that we know we own it we would like to have it blacktopped and get water and electricity there so we can have a Municipal parking lot and we could use it for a Farmers Markets, Food Truck sales, or just to be able to promote this to the downtown area.</u>
