## **OFFICIAL MINUTES**

- I. <u>Call to Order</u> President Block called the Board of Trustee Regular Meeting to order at 7:30 P.M.
- II. <u>Roll call</u> Members answering present as follows: Trustee Michener, Trustee Benes, Trustee Chambers, Trustee Marshall, Trustee Fruit, and Trustee Ziegler.
- III. Pledge of Allegiance President Block led us in the Pledge of Allegiance.
- IV. Comments from the Audience None
- V. Unfinished Business None

## VI. New Business -

- a. Discussion / Approval of 2022 Village of Kirkland Street Project, not to exceed \$2.5M, with Fehr-Graham and Northern Illinois Service Co. and Authority for President Block to execute contract - President Block informed the Board that they had the bid opening on May 12, 2022. We received 3 bids from William Charles, Norwest and Northern Illinois Service. Marten and Company put in a bid but were missing an addendum, so they had to be excluded. In the end, with everything included in the base bid and the alternative of Hortense and 1st Street, it came in at \$3.1M. Because we budgeted \$2.5M, we will need to remove the alternative of Hortense and 1st Street and the base bid would be \$2.5M without any contingencies. Jeff Jacobson spoke with Northern Illinois Service to see if there are other things that we could change for a cost savings. They suggested that we go from plastic pipe to concrete pipe at this time due to the concrete being cheaper than the plastic piping. We are going to look at more things like that so maybe we can do the base bid and more. Jeff and Village President Block also spoke with Village Attorney Bard Stewart about making these modifications. We are going to have to reject all bids and waive competitive bidding, negotiate with Northern Illinois Service Co. as in the end they were the lowest bidder. President Block asked for a motion for the approval to reject all bids and waive competitive bidding for the 2022 Roadway Project, authorize President Block to negotiate final terms with Fehr-Graham and Northern Illinois Service Co. not to exceed 2.5 million dollars. Trustee Ziegler made a motion for the approval to reject all bids and waive competitive bidding for the 2022 Roadway Project, authorize President Block to negotiate final terms with Fehr-Graham and Northern Illinois Service Co. not to exceed 2.5 million dollars. A 2<sup>nd</sup> was made by Trustee Fruit. On a roll call vote Trustees Benes, Chambers, Marshall, Fruit, Ziegler, Michener and President Block voted yes. Motion carried.
- b. <u>Discussion / Approval of Village of Kirkland Illinois 72 Gravel Lot Civil Site Design with Fehr-Graham</u> President Block explained that Fehr-Graham will do a site analysis so that we have the correct drainage, get a plot done and then send it off to the IDOT. Jeff from Fehr-Graham suggested that we may want to do this in phases. Trustee Chambers stated that we have received \$29200.00 from DDCF that we can use for this project. Trustee Chambers explained

that they will need to see quotes for each step and the minutes showing that they were approved. President Block feels that our first step would be to get the Engineering, electrical and water lines ran. Trustee Fruit would like to see the fencing and some fresh gravel done, this will let others know that it is ours and we are doing something with it. Trustee Chambers made a motion for the approval of Village of Kirkland Illinois 72 Gravel Lot Civil Site Design with Fehr-Graham with a 2<sup>nd</sup> by Trustee Ziegler. On a roll call vote Trustees Chambers, Marshall, Fruit, Ziegler, Michener and Benes voted yes. Motion carried.
